Preface

The need to have unemployment insurance data readily available for actuarial purposes, unemployment insurance research studies, and response to numerous inquiries prompted the compilation of this handbook. Whenever possible, we have attempted to provide annual historical data since 1960, and monthly data for current years.

The handbook is made up of six parts. Part I is entitled Legislative Action; Part II – Unemployment Insurance Fund; Part III – Covered and Noncovered Employment; Part IV – Experience Rating; Part V – Benefits, Contributions and Related Comparisons and Part VI – Claimant Characteristics.

The handbook contains a glossary and an index designed to assist the reader in understanding, interpreting, and to quickly find information.

The source of the data is primarily the Alaska Employment Security Division records. Other sources are designated on individual tables.

This handbook should be extremely valuable to economists and other planners in projecting economic trends. It will be updated yearly with additional tables and charts being added as needed.

PART I

LEGISLATIVE ACTION

There have been many changes in Alaska Unemployment Insurance system since it began on April 2, 1934. In Table 1 a historical review of the major changes is presented. Table 2 is a list of Unemployment Insurance tax rates applicable to experience rated employers for each reserve multiple range. The source of these tables are Alaska Unemployment Insurance laws.

- 1/ Under the Federal "additional credit provision", through experience rating a State is allowed to reduce U.I. taxes below the standard rate and still maintain the maximum credit against the Federal U.I. Tax for an employer with at least one year of payroll experience. Therefore on July 1, 1947, Alaska enacted an annual payroll decline experience rating formula. This formula was in effect through June 30, 1952. No experience rating system was in effect from July 1, 1952 through September 30, 1960. On October 1, 1960 a quarterly determined payroll decline formula was effective with variable rates. Prior to 1947 all contributions were lumped into a pool out of which benefits were paid.
- 2/ Although no benefits were paid until January 17, 1939, Alaska's first unemployment compensation law set the weekly benefit amount equal to 50% of the claimants full time average weekly wage or if no weekly wage records are available his high quarter wages would be divided by 13. The maximum benefit would be limited to high quarter wages of \$390 divided by 26.
- 3/ No earnings outside the high quarter were required for eligibility, meaning a claimant with covered wages in only one quarter could be eligible.
- 4/ This was the first year benefits were paid and the benefit computation formula was $1/20 \times$ High Quarter Wages (HQW). Maximum Potential benefits were limited to the lesser of sixteen times the weekly benefit amount or one-third base period wages.
- 5/ The allowance for each dependent was twenty percent of claimant's basic weekly benefit amount up to a maximum of sixty percent, rounded to whole dollars.
- 6/ The benefit computation formula changed to $2.1 - 1.1$ percent of annual earnings.
- 7/ The benefit computation formula changed to $1.8 - 1.1$ percent of annual earnings. Interstate benefit payments were limited to \$25.
- 8/ \$5.00 for each dependent up to a maximum of five dependents, not to exceed the basic benefit amount.
- 9/ The benefit computation formula changed to $1/100$ times annual earnings plus \$5.00.
- 10/ Interstate benefits reduced to \$20 effective March 30, 1960.
- 11/ The benefit computation formula changed to $2.3 - 1.1$ percent of annual earnings plus dependents allowance.
- 12/ Conforming with P.L. 91-373 nonprofit organizations and state hospitals + State institutions of higher education given the option to elect to make payments (reimbursable financing) in lieu of contributions.
- 13/ Interstate benefit payment restriction of \$20 was required to be removed by P.L. 91-373.
- 14/ \$10.00 for each dependent up to a maximum of three dependents, not to exceed the basic benefit amount.
- 15/ New or newly covered employers' tax rates determined by industry classification; may vary as they are assigned the average industry tax rate of experience rated employers in the same industry. Delinquent employers liable to pay the year's highest scheduled tax rate.
- 16/ Each tax schedule has a fixed employee rate for all employees independent from the ten employer rate classes.
- 17/ Each calendar year depending upon the reserve multiple of the U.I. Fund on September 30 of the preceding year one of ten (C through L) variable tax schedules is in effect. See table on following page.

1937 - 1972



COVERED AND NONCOVERED EMPLOYMENT AND WAGES





PART V

BENEFITS, CONTRIBUTIONS AND RELATED COMPARISONS

From Unemployment Insurance data useful calculations and significant ratios can be determined. Average Annual Earnings is the result of total covered wages divided by average monthly covered employment found in the E.S. 202 report. The Average Weekly Wage is one-fifty-second of the average annual earnings. Report E.S. 280 provided the amount of benefits used to make the comparison of benefits to contributions by industry. By dividing the amount of benefit payments by the number of benefit payments, the average weekly benefit amount was computed. Tables 37 to 45 give the number and amount of benefit payments and number of first payment for intrastate and interstate by industry and location.

1939 - 1974



1939 - 1974



GLOSSARY

Account, Experience Rating - An account of a rated employer which is maintained by the Employment Security Division for the purpose of determining the contribution rate of that employer on the basis of his experience with unemployment. A rated employer would be one with at least one full year of experience.

Base Period - A period of time prior to the benefit year in which a claimant must have had a specified amount of insured work in order to qualify for benefits. Wages earned during this period are used in determining a claimant's weekly benefit amount and his maximum annual benefits. In Alaska, the first four of the last five calendar quarters immediately preceding the date of the initial claim make up the base period.

Benefit Amount

Augmented Weekly Benefit Amount - The weekly benefit amount of a claimant with dependents including the allowance for dependents.

Average Weekly Benefit - The figure obtained by dividing the amount of benefits by the number of weeks compensated.

Basic Weekly Benefit Amount - The weekly benefit amount of a claimant excluding any allowance for dependents.

Maximum Weekly Benefit Amount - The highest weekly benefit amount provided in Alaska's employment security law.

Minimum Weekly Benefit Amount - The lowest weekly benefit amount for a week of total unemployment provided in Alaska's employment security law.

Weekly Benefit Amount - The full amount of benefits a claimant is entitled to receive for a week of total unemployment.

Benefit Cost Rate - The percentage which the total amount of benefits paid out of the unemployment insurance fund, for any consecutive 12 calendar-month period, bears to aggregate payroll of subject employers for the four most recently completed calendar quarters of the immediately preceding 12-month period.

Benefit Year - The one-year period beginning with the day an insured worker first files a request for determination of his insured status.

Claim - A request for benefit payment.

Claimant - An individual who has filed a request for determination of insured status or a new claim.

Interstate Claimant - A claimant filing outside the liable State. As used in this handbook, it is a claim filed outside Alaska on wages earned in Alaska.

Intrastate Claimant - A claimant filing within Alaska on wages earned in Alaska.

Contributions - Payments (including penalties and interest) required by the Employment Security Act to be made to the Unemployment Insurance fund by reason of insured work under the coverage provisions of such act. These provisions require employer and employee contributions in Alaska. The average contribution rates in Part V represent the amount of taxes based on payroll computed and due from rated subject employers rather than the average contribution rates in Part VI which are based on amounts received from rated, unrated (new employers), and delinquent employers.

Covered Employment - Service performed for an employer subject to the coverage provisions of the Alaska Employment Security Act or the Federal Unemployment Tax Act. Alaska requirement: employment of one or more at any time. Federal requirement: employment of one or more on each of 20 days and wages of \$1,500 or more during any calendar quarter. For definition of average covered employment see Average Weekly Wage.

Dependent - An individual who relies on the worker or claimant for at least half of his or her support.

Dependents Allowances - Special allowances provided to beneficiaries by reason of higher costs incurred from family responsibilities.

Monetary Determination - A determination as to whether an individual meets the earnings and employment requirements necessary for the receipt of benefits to demonstrate the claimant's recent and substantial attachment to the labor market; and if so, his weekly benefit amount and maximum annual benefits.

Nonmonetary Determination - A determination as to whether an individual meets requirements other than those affecting his insured status such as the Able to Work and Available for Work provisions necessary for receipt of benefits to demonstrate the claimant's continuing attachment to the labor market.

Duration of Benefits - The number of weeks for which benefits are paid or payable for total unemployment in a benefit year to cover a reasonable period during general economic conditions for which the great majority of the unemployed could be expected to find re-employment.

Duration of Benefits (Average) - The number of weeks obtained by dividing the number of weeks compensated by first payments.

Employer, principal - The covered employer from which the worker received the highest amount of wages during the calendar year.

Exhaustee - A claimant who receives the total amount of benefits to which he is entitled during his benefit year.

Experience Rating - A method for determining the contribution rates of individual employers on the basis of the employers' unemployment risk as specified in the Employment Security Act.

Federal Unemployment Tax - The excise tax of 3.2 percent (1970) on each covered employer's wages up to \$4200 for each employee imposed by the Federal Unemployment Tax Act (Subchapter C of Chapter 9 of the Internal Revenue Code) on subject employers. A Federal Tax Credit of 2.7 percent is allowed for employers in a state having an Experience Rating system or in a state whose tax rate applied to the employee's taxable wages is equivalent to 2.7 percent of \$4200. The difference between the 3.2 and 2.7 percent tax finances the administrative costs of the State employment security programs.

First Payment - The first unemployment insurance check issued to an individual during his benefit year.

Funds

Unemployment Fund - A special fund established solely for the receipt and management of contributions and earnings for the payment of unemployment insurance benefits. Included in this fund are monies in the benefit payment account, clearing account and unemployment trust fund account.

Unemployment Trust Fund - A fund established in the Treasury of the United States which contains all monies deposited with the Treasury by State employment security agencies to the credit of their unemployment fund accounts and interest accrued on such monies.

Highest Benefit Cost Rate - 4.33 percent (the benefit cost rate for the 12 months ending on August 31, 1958).

Industry, Principal - The industry in which a worker earned the highest amount of wages during a calendar year.

Insured Unemployment Rate - The annual total number of weeks claimed divided by 52 times the average covered employment.

Interest - This figure represents the amount of interest based on the average daily fund balance that is earned on the trust fund. The interest is credited to the trust fund account as of the last day of each quarter even though the actual computation is made prior to this date.

Noncovered Employment - Employment not meeting the employee definition in the Alaska Employment Security Act or Federal Unemployment Tax Act and therefore excluded from unemployment insurance coverage.

Payroll - The amount distributed by an employer to his employees for work done.

Rated Employer - See Account, Experience Rating.

Reserve - Multiple - the ratio of the reserve rate to the highest benefit cost rate.

Reserve Rate - The percentage which the total amount available for benefits in the unemployment fund on September 30, immediately following the computation date, bears to payroll for the consecutive 12 calendar-month period ending on the computation date.

Standard Contribution Rate - The Federal Unemployment statutory tax rate of 2.7 percent established in 1935 to meet the expected initial costs of the program.

Subject Employer - See Covered Employment.

Taxable Payroll - That part of the total payroll which represents the first \$10,000 paid to each employee in wages. The \$10,000 tax base was effective January 1, 1974.

Unemployment Rate - See Insured Unemployment Rate.

Average Weekly Total Wage - The result obtained by dividing the annual total covered wages paid for service in covered employment by a figure representing 52 times the average covered employment (12-month average of the number of employees in the pay period which includes the twelfth day of each month during the annual period).

Weeks Compensated - Weeks compensated are weeks of unemployment for which benefits have been paid.
